**Description:** As was evidenced in Session 1 & 2 focussing on the Shoulder Girdle & Shoulder Joint (by the way, both workshops are now available for independent learning via private Facebook Links), we know that the study of Human Anatomy is complex and deeply interconnected. The muscles featured in session #3 are the main muscles of the Trunk/Core. This highly interactive, hands-on approach to applied anatomy is guaranteed to inspire curiosity and confidence about how to condition muscles most effectively in an aquatic environment.

### Learning Objectives:

- 1) Become familiar with the muscles associated with the Trunk/Core: names, location and joint actions in their role as prime movers and/or stabilizers.
- 2) Select specific CALA Base Moves that activate the main muscles of the Trunk/Core region.
- 3) Practice stretching to elongate the Trunk muscles in both chest-deep and deep water.
- 4) Adapt exercises and stretches to accommodate participants with common conditions.
