Description: We know what the study of Human Anatomy is complex and deeply interconnected. The muscles featured in session #8 are the main muscles of the Gluteus Maximus & Hamstrings. This highly interactive, hands-on approach to applied anatomy is guaranteed to inspire curiosity and confidence about how to condition these muscles most effectively in an aquatic environment.

Learning Objectives:

- 1) Become familiar with the muscles associated with the Posterior Hip and Posterior Thigh: names, location and joint actions in their role as prime movers.
- 2) Learn specific CALA Base Movement sequences that activate the main muscles of the Posterior Hip and Posterior Thigh.
- 3) Practice stretching to elongate the Hamstrings and Gluteus Maximus muscles in both chest-deep and deep water.
- 4) Adapt exercises and stretches to accommodate participants with common conditions.
